- 3. By adding a new Article 28 of the General Bylaws, entitled "Wetlands Bylaw" comprised of Sections including I. Purpose, II. Jurisdiction, III. Applications for Permits and Requests for Determination, IV. Notices and Hearings, V. [Omitted], VI. Permits and Conditions, VII. Setbacks, VIII. Regulations, IX. Definitions, X. Enforcement, XI. Burden of Proof, XII. Appeals, XIII. Relationship to the Wetlands Protection Act, and XIV. Severability.
- 4. By adopting a certain Petition for Article for Annual Town Meeting entitled "Regulations, Bylaws, & Policies for Berkley Massachusetts", the complete text of which is on file with the Town Clerk's Office and can be viewed at the Town Clerk's Office during normal business hours.
- 5. By adopting a certain Petition for Article for Annual Town Meeting entitled "Right to Farm", the complete text of which is on file with the Town Clerk's Office and can be viewed at the Town Clerk's Office during normal business hours.

The Board voted to open the Public Hearing. Resident Robert Rose of 93 Locust Street questioned what the benefit of changing the zoning v. special permits would be; he also questioned if it opened the Town up to new warehouse issues, etc. It was confirmed that the Planning Board will also be holding a meeting to discuss the matter and anyone with questions was encouraged to attend that meeting for further clarity. David Patrick of the Conservation Commission provided a brief overview of the Wetlands By-Law. It was confirmed that the proposed By-Laws are nearly identical to current ConCom By-Laws throughout the State, with specific amendments to benefit Berkley. The purpose of the proposed By-Law is ultimately to allow ConCom to enforce state laws as opposed to DEP. George Faria of the Conservation Commission reiterated that without the passing of this By-Law, they have no authority. George Faria also provided a brief description of the Right to Farm Petition. He reaffirmed that passing the Right to Farm does not change any farming practices that have been going on for 100+ years. It was also suggested that with the Right to Farm, there is a possibility of agricultural grants. It was reconfirmed that dogs and all other domestic animals are not included. Resident Darcy Giardini of Howland Road voiced concern over ambiguous language and questioned why it was important to get this passed now. It was confirmed that this does not give farmers any further rights than currently available. It was confirmed that any Citizens' Petition with 10 or more registered voter signatures were legally required to appear on the Annual Town Warrant. The Board voted to closing the Public Hearing.
