New Business	<p>The Board of Selectmen voted to open the Pursuant to Article 23, Section 5 of the Town of Berkley General Bylaws, notice is hereby given that the follow amendment will be considered by the Personnel Board at its meeting of Wednesday April 14, 2021 at 6:00pm at Town Hall 1 North Main St, Berkley, MA 02779 in the Moitoza – Pettey Hearing Room:</p> <p><i>I General Provisions, Section 1.4 Definitions</i></p> <p><i>APPOINTING AUTHORITY – An appointing authority shall mean any official, board or commission authorized by the general law, bylaw, or Town Meeting vote to appoint employees. Elected officials shall may be considered appointing authorities. <u>Only elected officials with statutory or bylaw appointing authority will be considered appointing authorities, otherwise, the Board of Selectmen shall be the appointing authority.</u></i></p> <p><i>Department Head – A department head shall mean the officer responsible for supervising a department's operations and activities: an appointing authority may be a department head and a Department Head may be an elected official.</i></p> <p><i>Example: The elected Highway Surveyor and Tree Warden if the same person would be the department head for the Highway Department.</i></p> <p>The Board of Selectmen voted to open the public hearing.</p> <p>Mr. Miller read the letter into the record from Town Council regarding appointing authority. He stated that the Board of Selectmen has been acting as the appointing authority and hiring for over a decade and that the policy was changed at Town Meeting in 2003. He also mentioned that they commonly refer to the department heads. Mr. Miller read the current personnel bylaw into the record. Mr. Miller gave an overview of the situation. Ms. Joan Blake stated meeting that things did not work out the way it was supposed to and noted about the assessor clerk position that was voted at town meeting and was taken down. Mr. Joe Freitas stated that the full-time assessor position was funded from the clerk position. Mr. Robert Rose, Highway Surveyor, read the appointing authority bylaw into the record and said it was concerning as a department head as it only references the appointing authority and not the department head. Mr. Miller noted that Town Meeting was coming up and that they would take a look at them. Mr. Joe Freitas stated he agreed with Mr. Rose and stated that it needs to be more easily understood. He also mentioned that he thinks more people should be involved, like the town administrator. He read the conflict-of-interest law and thinks personnel bylaws should be rewritten. Mr. Robert Cayton stated that it is important to refer to department heads and stated that the Board of Selectmen were putting all of the responsibilities on themselves. Mr. Miller stated that the Board of Selectmen do all of the hiring except for Board of Health, who is exempt by state law. a strong chief is allowed to fire, but still brings them in to be hired. Ms. Karen Coolus asked for a copy of the letter from Town Council regarding appointing authority. She agreed with Mr. Rose's comments about the bylaws and how the hiring is done. She stated that just because it has been done for 10 years doesn't mean it is right and thinks they should go back and look at all the issues. Mr. Miller noted that it is hard to get anyone to participate in regards to making a personnel board. Ms. Lisa Tetreault, referring to the assessor's position, stated that that position was filled years ago. Mr. Miller stated that to his understanding, the Board of Assessors addressed their needs and funding was through that clerk position. Mr. Freitas stated that the Town Assessor's position was effective 7/1/2020 and in November Special Town Meeting, the remaining town money remained in the clerical position. Ms. Deborah Pereira questioned why this is all coming up right now. Mr. Miller explained that it was brought to their attention by an outside union representative but there is no indication that they are trying to do anything differently. Ms. Pereira stated that after reading through the rules, there is protentional of how things could change. She stated she thinks it should be addressed and reworded before they make a change. The Board of Selectmen voted to close the public of the hearing of the personnel bylaw change.

Cochrane motion to close public input, Larabee 2nd voted

Mr. Larabee stated that he thinks there is a number of things they need to do and noted the need to modernize. He also noted that he thinks it would be beneficial to speak before public input. He also mentioned that he agreed with Mr. Rose and stated that they should look at it all at once and update the definition of a personnel board and the composition of a personnel board, as it all depends on how it is defined. Mr. Miller stated that an idea is to include the Town Administrator and the department head would act as the 5th member if it pertains to their department. Ms. Cochrane noted that in the past, the personnel board was made up of 2 elected officials, 1 Selectmen, and 2 citizens at large. Ms. Melinda Paine-Dupont stated that having all three Selectmen is not separation of power and that the process is problematic. She stated that it was good to have checks and balances and thinks this should be tabled until all rules can be looked at as it is obvious that the people of Berkley have a problem with what they are trying to do. She stated that they are disregarding the voters. Ms. Cochrane stated that should would not want certain things taken away from her as a Department Head. She stated that she doesn't agree that the Board of Selectmen should discipline. She noted, as far as hiring people, department heads post the positions, interviews, and then bring in the top candidates to be interviewed by the Board of Selectmen. She noted that it is the same process for hiring Police officers and thinks it is a good process. She did mention that she agrees with Mr. Rose that the laws are confusing and can contradict themselves. She stated that they need to look at the personnel board as a whole and maybe go back to just 1 Selectmen. Ms. Cochrane also stated that she doesn't feel comfortable being on the personnel board and being a department head. Mr. Miller noted that it is difficult to get people on committees and brought up other issues. He stated that he believes it should be made up of officials already in town government and is cautious about the citizen at large. Mr. Larabee started that he thought the conversation was very useful and thorough and would like to see everything adjusted at once. Mr. Miller stated that if there is an issue that they think is not beneficial to the town, it will be addressed. He stated that he disagrees that people think the Board of Selectmen shouldn't be on the personnel board at all, as the Board of Selectmen is an executive branch of the town. The Board of Selectmen voted to table personnel bylaw change.
