The School is also giving free bagged breakfast and lunch that can pick up Monday – Friday at BCS. The Town is currently closed of the public until further notice. Residents can call the Town Department if there is town business needs to be done beyond anything that can't be done electronically. The Library is closed to the public until further notice. The Historical Building is closed. The Public Safety building is trying to keep just the front vestibule open and if they need to enter the building will be evaluated on a case by case basis. They have stopped child safety seat classes, and the renewal or new issuance of LTC. A renewal of a LTC will carry out for 60 days as does the DMV has also implemented. The COA is closed to the public initially for 2 weeks and trips for at least 30 days. The Town playgrounds at BCS and the Common are also closed. Asked the BAA to cancel their cleanup day and Easter Egg hunt. The Transfer station is only open to bagged trash only. All information is posted on Town Website as well as my Town Administrator Social Media Page. Currently 5 Confirmed cases in Bristol County and none at our town at this time.
