70% of teachers are in the top step. The first year is retro. The first two years were budgeted for, however the increases in the last two years will be coming from staff reductions and the teachers are aware of that.

Meeting with Highway Surveyor to discuss letters he had sent in to the Board. Rose stated that since he was interviewed this is his first time in front of the Board other than at the Annual Town Meeting. There was an issue at the Town Meeting where he stated that he never said he would be in favor of his position being changed to an appointed position instead of an elected one. Mr. Rose then said that since then he has had an opportunity to review the tape and apologizes because he did in fact state that he would support and be in favor of his position being changed to appointed. He offered his sincere apologies and stated please keep in mind this is a huge step for me. He would like to own up to it. Miller feels it was unfortunate because it caused other people to be drawn into it. It is our job to work with other Boards and Officials not to have squabbles. Rose stated he feels as though the people would like the right to elect their Highway Surveyor and he feels that the greater people should have a say as to how the Government runs. Sterling stated that she appreciated him coming in after he reviewed the tape and setting this straight. Rose stated that he is willing to work with any Department that is willing to work with him. Miller mentioned that in his interview for Highway Surveyor and when they hired him, Rose had a very strong stance and stated he is not a Politian he felt it should not be elected. That was an important issue for the Board but they also felt he was a good candidate and good for the job. Miller asked the Town Administrator to address the letters sent it. Coutinho stated that he takes his orders from the Board of Selectmen. He then went on to not that the letters from Rose said things he did not say and he has lost a lot of trust. Coutinho never stated that he could not come into the Town Hall, what he stated to Mr. Rose was after what took place at the Town meeting he would like to be notified when he plans to come in to speak to his employees, he would never tell Rose that he couldn't come in he is elected. He then stated that once again this was put on social media but we have it on tape and we can watch it. Mr. Coutinho stated that he would never call up one of Rose's

Mr. Coutinho explained how the Ch. 90 should be done. He also noted that the Town Accountant got written up because the Ch. 90 was not done correctly. He stated that the Selectmen are the deciding vote on what Ch. 90 projects are to be done. They are to come to the Board and describe what they think should be done and the Board votes ves or no. Mr. Rose stated \$261,000 had been awarded. District 5 contacted him and told him there is a lot more money than that for them. There is another \$135,000 that had been awarded in the past back when Paul was working and the Highway Surveyor was never notified. So they now have \$402,899.02 to spend. He then went on to explain why he picked the streets that he did. Coutinho noted that he asked for the reports ahead of time because it makes it easier and faster. Miller stated that in the future it would be better to have the reports ahead of time.
