**REGULATION PROHIBITING INSTALLATION/USE OF PRIVATE WELLS ON
PROPERTIES CAPABLE OF CONNECTING TO HOLLOWAY STREET/COUNTY
STREET WATERLINE EXTENSION**

1. Authority

In 2022, the Town of Berkley, City of Taunton, and Waste Management Disposal Services of Massachusetts, Inc., entered into Agreements concerning a waterline extension (the "waterline") that would service the residences of Holloway Street in Berkley due to health risks posed by ground water in the Holloway Street and County Street areas.

Pursuant to M.G.L. Chapter 111, Section 31, as amended, upon completion of the waterline extension project along Holloway Street and upon completion of the waterline loop along County Street, the Town of Berkley Board of Health hereby bans the new installation, maintenance and operation of Private Wells new or existing on any properties including all residential units, commercial units, or industrial units that are capable of connecting to the waterline.

2. Penalties

Whosoever violates any provision of this regulation may be penalized by the non-criminal method of disposition as provided in the Mass. General Laws. Chapter 40, Section 21D or by filing a criminal complaint at the appropriate venue.

Any person who shall violate any provision of this regulation for which a penalty is not otherwise provided in any of the General Laws or The Sanitary Code shall upon conviction be fined not less than \$10.00 nor more than \$50.00.

3. Enforcement

Enforcement of this regulation shall be by the Board of Health of Berkley or its designated agents.

Any person may bring to the attention of the Board of Health any alleged violation of this regulation and upon receipt of such allegations the Board of Health shall undertake whatever investigation and enforcement it deems appropriate.

4. Severability

If any provision of this regulation is declared invalid or unenforceable, the other provisions shall not be affected thereby but shall continue in full force and effect.

In the event any provision of this regulation shall conflict with any other regulation promulgated by the Board of Health, this regulation shall govern.






