



## **Minutes of the Meeting**

2. **6 Bay Meadow Road**

The Septic Plans were reviewed by our consultant Nyles Zager. The Board reviewed the comments and the plans. Dan Fournier made a motion for (2) variances 150% design criteria for soil absorbsion system and reduction in water table separation to bottom of SAS from 5ft. to 4ft. Ann Marie Rapoza – Sec – All in Favor for both variances. The Board approved, stamped and signed the plans, given to Gerald Bernard.

3. **7 Beach Street**

The Septic Plans were reviewed by our consultant Nyles Zager. The Board reviewed the comments and the plans. Dan Fournier made a motion for (2) variances - reduction in sideline setback distance from 20ft. to 18ft. and the 150% sizing requirement of the absorbsion system. Ann Marie Rapoza – Sec - All in Favor for both variances. The Board approved, stamped and signed the plans, given to Gerald Bernard.

4. **101 Seymour Street**

Keith Bliss appeared before the Board for the Certificate of Compliance. The Board reviewed the As-Built and the Sieve Test, copies placed in folder. The Board approved, stamped and signed, COC given to Mr. Bliss.

Dan Fournier made a motion for a variance to allow the S.A.S to be designed for 100% of the Title 5 requirement, instead of the 150% requirement – Ann Marie Rapoza – Sec – All in Favor. The Board approved, stamped and signed the plans. The plans will be held until the fees are paid (Variance - \$125.00 & Septic Permit - \$375.00).

9. **34/38 Padelford Street**

Doug Mann from DM Drilling Services appeared before the Board with an application for a Well Permit. The Board accepted, fee of \$275.00 was paid with check #1110. Pink copy of the Well Permit given to Mr. Mann.


10. **5 James Way**

Meeting ended at 7:51 PM.


