Appointments

The Board had a discussion with Carl Malloch regarding Ferry Lane. Mr. Rose the Highway Surveyor stated his concerns with how the road was to be constructed and that he did not want it to cost the Town more money in maintaining it over the years if done incorrectly. Rose stated that he would not have enough money in the budget if they allowed him to use ground asphalt but that he would consider allowing them to use double chip sealed. Malloch stated that Rose is correct and that it would need to be maintained more than a normal road if they only used the ground up asphalt like they were intending. Rose provided documentation that showed they were to build the road to meet the current roads already constructed in Berkley. Donna Leary stated she wanted them to have an approved plan before constructing the roadway. Cochrane stated that everyone had a valid point and that the issues needed some sort of solution possibly with the double chip sealed and that it was not going to be feasible for Rose to maintain if done with just the crushed asphalt. The Board agreed they would like to attend the next meeting pertaining to this issue.
