## Notice of Intent Filing procedure.

**1.** Applicant MUST contact the Conservation Commission to receive a hearing date. \*\*\*\* After you receive a hearing date:

2. Applicant must properly fill out 2 copies of a NOI, along with 2 copies of any plans signed and dated by Engineer, along with the proper filing fee.

(Individual Notice of Intent filing is required for all lots.)

\*\*\*All plans MUST be signed and dated by the Engineer that drew them. \*\*\*

Changes to existing plans will not be accepted.

Form T MUST be filled out & signed properly (with the tax collector)-This is provided in packet.

#### 3. Applicant must get a Certified Abutters List from the Assessor's office. (Requires 10 working days)

4. All abutters must be notified by Certified mail or Certificate of mailing, on the form supplied by Conservation Commission. Abutters MUST be notified at least 7 days prior to the hearing date.

#### 5. Hearing date MUST be posted in the Taunton Daily Gazette.

(The requirement in the Act & Regulations: the legal notice must be published at least 5 business days prior to the hearing which does NOT include Saturday or Sundays. If the newspaper fails to publish the legal notice 5 business days before the public hearing, the hearing cannot legally be opened, and a new notice must be published.)

\*\*\*\* Please be aware, if your NOI paperwork is NOT complete or you do not have all required documents the night of the hearing, in some cases the hearing will NOT be opened OR it will be opened but continued to be voted on once all documents are received\*\*\*\* This is the responsibility of the APPLICANT \*\*\*\*

6. The <u>secretary</u> will file the Town clerk's posting in the Clerk's office at least 48 hours prior to the hearing date.

#### Night of the Hearing applicant MUST HAVE ALL of the following:
