- The Public Hearing form & date, provided in this packet must be posted in **Taunton Daily Gazette**.

(The requirement in the Act and Regulations: the legal notice be published at least five days prior to the hearing which **does not** include Saturday & Sundays. If the newspaper fails to publish the legal notice five business days before the public hearing, the hearing cannot legally be opened, and a new notice must be published.)

- The form "T" supplied in this packet must be signed & dated by the Tax Collector & returned to the Con Com along with the complete packet. Failure to have this form properly filled out, WILL result in not opening the hearing.
- 4. The Town clerk's Agenda will be posted by OUR Conservation Commission's Secretary.
- 5. The Commission requires 2 copies of the RDA & 2 copies of plan, marking location of work to be performed. As well as proof of receipt by Department of Environmental Protection (DEP)
- 6. This paperwork MUST be complete & turned into our Commission 1 week prior to the hearing. (Failure to get in on time will result in not being put on the Agenda.)
