CHILDREN'S LIBRARIAN'S REPORT

Erica Grady submitted a report from October 11, 2022 through November 8, 2022: There were approximately 117 visitors to the Children's Room. Four Story Times were held with 24 in attendance. Four VolunTEENS contributed a total of 82 community service hours this month. The Children's Room newsletter is now reaching 87 people. Marketing continues to be created across all social media platforms, library and town websites as well as through the distribution of print materials placed around the library. PACE Play and Learn Together was held October 14 with 8 in attendance. Miss Tammy will be back monthly starting December 9. This program is free for ages 0-8 and their caregivers. LEGO Night was held October 20 with 28 in attendance. The Spooky Pumpkin Walk was a success on October 28 with approximately 120 in attendance. The VolunTEENS set up spooky stations and Carol Buote offered a popular palm reading station. The Pokemon Trading Card Club attended their first monthly get-together on November 5 with 26 in attendance. Future events include Craft Night on November 16 from 5-7 p.m.; Lights On December 11 and Winter Reading BINGO with Beanstack on January 23, 2023.

DIRECTOR'S REPORT

The Book Club met on November 3 with 5 attendees and discussed *The Sentence* by Louise Erdrich. For the December 1 meeting, they will read *The Royal Nanny* by Karen Harper. The Knot Just Knitting Group met on October 12 with 4 attendees and October 20 with 4 attendees. Carol Buote attended the SAILS meeting on October 19, when they discussed materials challenges which are on the rise. They continue to work on security improvements, including removing title/author from patron notifications. Amy Mursko catalogued the 3 donated

Deadlock Mystery Society game boxes, which are for ages 13+ and include puzzles, evidence and hidden clues to solve a mystery. The Director discussed and reviewed the FY2023 budget. She attended a Town Hall Meeting on November 20. All departments will now need to use receipts for any fees received. There will also be a review of town salaries. Senator Marc Pacheco requested to attend a Meet and Greet on October 13.
