Mr. Lynch referenced the resignation and retirement letters received to date, all related to Covid-19. The BMS, BCS, Preschool and Kindergarten handbooks were circulated electronically to the Committee.

AGENDA ITEM #5: PUBLIC INPUT

A member of the public thanked the administrators and committee for all their hard work this summer planning and preparing for school re-opening.

AGENDA ITEM #6: EDUCATIONAL REPORTS

AGENDA #6a: PLANS FOR RE-OPENING SCHOOLS

Mr. Lynch reported that based on input received the parent Info. Sheets, to date we have 49 remote students at BCS and 25 remote at BMS and have seen an increase in home schooling requests. All other students will return to school in the hybrid model. Mrs. Francisco explained the two remote platforms. Grades 6-8 platform is Edgenuity; Grades K-5 platform is the Florida Virtual School (FLVS). Additional information will be provided for the total remote learners as it is obtained. She explained there is a contact person in MA who will be working with us on the platforms. The remote learners will be monitored by teachers at BCS and BMS. Unified Art lessons will be taught by the BPS UA teachers; they will record lessons.

It was explained that additional information will be going out to parents in about ten days. A tour is scheduled for incoming grade 5 students. A video will be sent out to BCS students very soon, after the light replacement project at BCS is complete. Preschool and Kindergarten families will be sent power point presentations. Individual classroom letters will go out from teachers next week. On Oct. 11 there will be open houses for K and Preschool. BMS families will be sent electronic letters with supply lists for each grade. Schools will look different from last year. A digital walk thru of the buildings will be done once the buildings are ready. Information was shared about drop off and pick up procedures as well as transportation.

Mr. Lynch announced we will have 1:1 chrome books for every student in grades 2-8. 150 were ordered in the spring and the town is using Covid funds to purchase us 448 more.

As reported earlier, the grades 6-8 platform is Edgenuity; Grades K-5 platform is the Florida Virtual School (FLVS).

AGENDA ITEM #7a: SOMERSET BERKLEY REGIONAL SCHOOL COMMITTEE

Mrs. Vincent reported that the high school adopted the remote learning plan to start the year and will move to hybrid later in the year. No decision has been made about fall sports yet.

AGENDA ITEM #7b: FACILITIES UPDATE

Mr. Lynch reported that all lights in the grade 1-4 classrooms at BCS have been changed. Kindergarten is next and then the hallways, gym, café and parking lots. Custodians have been working hard to assist the electricians working on this project and do all the summer cleaning as well. He explained that desks will be spaced out 6' apart in the rooms and in the cafeteria for lunch and breakfast.

AGENDA ITEM #8: UNFINISHED BUSINESS

AGENDA ITEM #8a: BCS & BMS SCHOOL IMPROVEMENT PLANS (SIPs) 2020/21

Mrs. Francisco and Mrs. Hebert spoke about their improvement plans and changes that were made as a result of the pandemic and subsequent remote learning options. It was noted that they may need revising again as we move through the year.

AGENDA ITEM #9a: SUBSTITUTE PAY RATE FY '21

As expected, many substitutes will not return this year and it is difficult to get new ones. Many districts raised their rate for this year. Mr. Lynch reviewed recommended rate increases for FY '21 for substitutes: Teacher/Certified \$145/day; Teacher/4 year degree \$135/day; Teacher/2 years college \$18/hour; Paraprofessional \$14.50/hour; Registered Nurse \$200/day

It was moved by Mr. Fagan, seconded by Mrs. Vincent and VOTED to approve the substitute pay rate increase for FY '21 as presented.

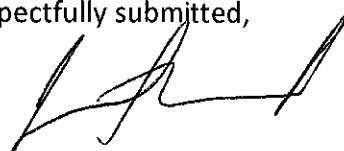
