# AGENDA ITEM #7a: PRINCIPALS' REPORTS ON SCHOOL ACTIVITIES

have been held. The parent survey was sent to all families.

BCS: Mrs. Francisco reported that Preschool and Kindergarten screenings are complete. The Activities Committee has postponed the annual Craft & Vendor Fair. An online book fair will be held and spirit wear order forms were sent home. DIBELS testing is complete for all students in Grades K - 4. Berkley Fire Dept. partnered with the schools again this year to instruct students on fire safety. Online lessons will go home to all students this week. Start of year fire drills and bus evacuation drills

BMS: Mrs. Hebert reported that Bristol Plymouth and Somerset Berkley will share their high school information virtually with our grade 8 students. Student Council elections will be held later this

month, under Mr. Wheeler and Mrs. Thorne's leadership. After-school intramural cross country and soccer programs are underway. The parent survey was sent to all families.

Mr. Lynch provided the School Committee with a draft of the full remote plan that would be implemented if Berkley Public Schools has to go that route in the future. He explained that students would log in to their respective teachers and follow similar schedules to what they now have. The draft has been sent to the teachers' union for their review. He asked School Committee members to send him any comments/questions about the plan.

# AGENDA ITEM #8a: SOMERSET BERKLEY REGIONAL SCHOOL COMMITTEE

Mrs. Vincent reported that the high school is now operating under a hybrid model. A tri-district committee meeting with representatives from the Berkley K-8 SC, the Somerset K-8 SC and the Somerset Berkley Regional High School SC was held to begin the review the regionalization agreement and to update language in the agreement.

## **AGENDA ITEM #8b: OCTOBER 1 ENROLLMENT**

October 1st P-8 enrollment was 867 which includes 110 Choice students. Last October 1 our enrollment was 916 with 108 Choice students. Mr. Lynch reported that a group of superintendents and legislators are working to keep Chapter 70 funding this year the same as last year. Chapter 70 funding is based on enrollment. Enrollment in many districts, like ours, has declined because some families opted not to send their Kindergarten students to school this year and the number of home school students has increased.

## **AGENDA ITEM #8c: TECHNOLOGY UPDATE**

We have been told by our vendor that there is still a backlog of districts waiting for Chrome books. To us, it is manageable right now; it will be more of an issue if we have to go full remote. We currently have about 250 Chrome books out on loan to families.

The budget timeline for 2022 was shared. The proposed budget will be given to the Committee at their December meeting and presented in January. Once approved, it will be forwarded to the Finance Committee. The state has not released any budget numbers for next year yet.

According to town meeting, acceptance of the provisions of Chapter 71, Section 71F, allows the School Committee to accept and expend tuition payments. The Berkley School Committee annually sets the rates for the year. Although not often needed, they are in place in case a chargeback to another town is in order, i.e. Lindencroft student. It is recommended rates be increased by 2% as listed below; rates have not been increased in several years.
