### AGENDA ITEM #6a: PRINCIPAL'S REPORTS

BMS: Mrs. Hebert reported on the results of the parent survey. 168 responses were received; responses were evenly spread between the four grades and the two cohorts. 84% agree with health and safety protocols that are in place at BMS. 52% feel students are working well with remote learning. Some families want the learning to be more rigorous and others feel it is too rigorous. Teachers continue to work together for continuity and relevance across the board. Grade 5 virtual students are using FLVS and Grade 6-8 students are using Edgenuity. 80% feel their students are able to navigate Google classroom and most believe the school has good communication with parents. She reported there was some concern expressed about early drop offs in the morning relative to social distancing. To address this, now students may be dropped at school starting at 7:50 AM and will report to the cafeteria to wait for the start of school. Breakfast is still free for all students.

BCS: Mrs. Francisco reported on survey results from Community School parents. 245 responses were received; the majority are in support of efforts being utilized for in-person, remote and virtual learning. Overall there is a high degree of satisfaction in just about every area including learning models, transportation, health and safety, and learning platforms. Communication is a strength for BCS with 94.3% giving a favorable response. All survey comments/trends are being reviewed to see where improvements can be made. A suggestion regarding remote learning specialist requirements resulted in changes to the classes required. Now families are to complete four specialist classes over a two week span. A reoccurring suggestion was to return to full in-person learning, which can happen only when regulations are eased to allow the school to meet the social distancing requirement with an increased numbers of students.

Mrs. Vincent stated four policies are recommended for 2<sup>nd</sup> reading, three are related to COVID and asked that these be shared with families. MASC recommends a change to the Inoculation of Students Policy #6305 based on new regulations that require all school-age students receive the influenza vaccine by year end. A concern was expressed about changing policies temporarily due to Covid. It was asked "what happens to students who are not inoculated against the flu by the deadline?" It was suggested that policies related to Covid be combined into one rather than changing individual policies temporarily. The Policy Subcommittee will further review this at its next meeting. 2<sup>nd</sup> readings were postponed to the next meeting. A new policy that addresses development and adoption of curriculum was recommended for first reading.
