Business zoning district:109 Padelford St(MAP 16 LOT 81-27); 113 Padelford St(MAP 16 LOT 84); 120 Padelford St(MAP 16 LOT 85); 122 Padelford St(MAP 16 LOT 85-02); 124 Padelford St(MAP 16 LOT 85-01); and portions of the properties at 9 Hill St(MAP 16 LOT 81-15) and 18 Heritage Dr (MAP 16 LOT 81-16) limited to a depth of 150' as measured in a Southerly direction from Padelford St; and by adding new subsection G to Art. 21 Section 5 for Corner Lots; and amend Art. 21 Section 3-Definitions by replacing the definition for Frontage.
