| Appointments | - Meeting with the Zoning Board of Appeals regarding a personnel matter. Marcus Baptiste, ZBA Chairman spoke about a pay raise for their secretary requesting a new pay of \$20 per hour. Miller asked what her responsibilities were. Baptiste stated what heather does such as, minutes, schedules meetings, deals with the public, sends certified mail, customer service, puts away files, and currently makes \$15.12 per hour. The secretary work 20 hours per month on average. He then again stated he would like to raise her up to \$20 per hour. Miller asked when her last pay increase was, ZBA Secretary Heather Almy said it was a year and a half she went from \$12 to \$15.12 an hour. Miller noted that was a \$3.12 an hour increase. Baptiste stated they have \$12,000 in revolving fund in their account. They collect two fees from applicants: one for expenses and they have very minor expenses. And another that essentially covers her pay. Miller and Baptiste discussed that it is a \$5 an hour increase in pay they are asking for. Miller asked what they anticipate happening with the account they intend to pay her from. Baptiste said he compared their fees to other town's fees and Berkley ZBA fees are very high. He felt Berkley ZBA should lower their fees. Miller asked if he felt their fees are causing people not to develop. Baptiste said no, but he also doesn't think the department is supposed to be a profit generator. Miller advised that they also have to think about dry times. Marcus stated they deal mostly with homeowners not developers. The last developer that applied was denied. Miller discussed creating a tiered fee to help the residents. Marcus will get more info for Miller. Cochrane stated they have to go by the Bylaw and be paid by the grid and they can't just give a person a \$5 hour raise off the grid. Cochrane stated that she is not saying she is against it but that they need to work on fixing the grind because come January the grid will be obsolete. Cochrane | Informational – No action taken |

noted that there are Town employees with special licenses that are making less than her at \$13 an hour. Cochrane suggested scheduling a Personnel Board meeting to discuss the grid. Heather Almy stated that when the money went down she worked two hours a week, and questioned who else would do that. Carma of the ZBA questioned if there was litigation against the ZBA where the funds would come from. Baptiste stated the ZBA would doesn't have enough funds to cover litigation. Leary asked Cochrane to talk about the Bylaws she referred to regarding the grid. Cochrane stated it may have been Rules & Regs or Bylaw and that she wasn't exactly sure. Cochrane stated that the Town Accountant said in order to do a classification change they would have to do a hearing. Baptiste asked if they could do anything on the current grid to give Almy a raise. Cochrane noted they just raised her from a Grade 8 to 10 and need to look at this because Almy is a Grade 10 and max pay she can get is \$15.10 per hour unless they add more duties and then they can reclassify her. Baptiste stated there was nothing else more they could possibly add for her. Cochrane suggested they get a copy of Almy's job description and see. Sterling stated she hoped to have the Personnel meeting before the holidays. Baptiste and Miller discussed smaller fees. Mr. Coutinho stated the money their department generates should be in a Town budget and not a revolving account. Coutinho stated that the Town should fund the Boards that way should they need things like council it is covered. Anything that generates fees should go to the Town to fund general funds and not just back to that department. Freitas stated it should go to local receipts and the money of the revolving should be part of the Town assets. Almy stated she remembers years ago when the departments account was down to \$200 and the Finance Committee refused to help them. Freitas explained to her that funding what they were asking was not allowed unless it is an emergency. They are not to fund whatever the department wants it has to be an emergency. Miller stated he would like to move sooner rather than later on the matter. Castellina presented a letter asking the Board to address the secretaries in Town are not being paid the same as other surrounding towns. He also noted that without their clerical the Boards would not function. Castellina felt that they aren't union employees but they work just as hard. Miller mentioned the non-union have a fraction of the hours that the union employees have. The non-union employees are working a couple hours a week max vs. 22 hours a week. Castellina noted that the Appeals Board gets less applications than Conservation Commission and the Board of Health or Planning Board. He feels that all clerical should get a raise. Cochrane stated her goal before the next meeting is to have a plan of attack and to talk to other Boards to open this up. Miller wanted to look at a potential modification of fees, work on the grid, and look into moving from revolving accounts to general funds. Cochrane asked where they got a \$20 dollar an hour pay form. Baptiste stated the minimum wage is at \$12 right now and going up. He just figured she does everything for them.
