Ladies and Gentlemen:

Please be advised that the MassDOT Highway Division has contracted with J.F. White Contracting Company as the general contractor on the listed public works construction project. We are writing to you as your organization is either listed by DigSafe and/or MassDOT as a utility owner having utilities within/crossing the railroad Right-of-Way or you are a non-member municipal utility owner with the potential to have utilities within/crossing the railroad Right-of-Way. Therefore, in accordance with Contract Specification Section "Notice to Owners of Utilities" and Chapter 370, Act of 1963, Massachusetts, we hereby provide this written notification to the listed and potential utility owners and officials of our intention to perform earth excavation on the MCRR Right-of-Way. Please respond and identify all utilities located within the Massachusetts Coastal Railroad, LLC (MCRR) Right-of-Way. We look forward to working with your organization to respect and protect your utilities, while safely performing our Contract Work.

The proposed work consists of replacement of the (4) small Bridges along the South Coast Railroad line in the towns of Berkley, Lakeville and Freetown. Bridge Name and numbers are as follows: North Cotley B-08-004, South Cotley B-08-005, Cedar Swamp River L-01-018 and Fall Brook F-09-028. The work also consist of installation of approximately 900LF of new track, approximately 4000 LF of permanent sheet piling for global stability, handling and disposal of contaminated/hazardous soils, installation of H- and mini piles, Precast bridge seats and wingwalls and a 7'x7' by 38' long box culvert. The Contract Work includes site clearing, excavation and grading, erosion controls, and environmental controls.

The excavation work of the project is expected to commence on or after June 15, 2019, with an expected completion date of 11/23/20. Due the distance from any intersecting roads, Latitude and Longitude coordinates will be provided to obtain DigSafe Ticket Numbers.
