He explained that the town has extra free cash from an audit and feels this is the time to play catch up Moderator closes Article 2

A motion was made by George Miller that the Town transfer from the Somerset/Berkley Regional School District stabilization fund the sum of \$2,581,970. 00 to pay its assessed share of the Somerset/Berkley Regional School District Budget for fiscal year 2020.

ARTICLE 8. A motion was made by Wendy Cochrane that the Town vote to authorize expenditure limitations for the following revolving funds pursuant to G.L. c. 44, § 53E<sup>1</sup>/<sub>2</sub>, for the fiscal year beginning July 1, 2019, to be expended in accordance with Article 35 of the General Bylaws: wiring inspector, \$10,000; gas inspector, \$10,000; plumbing inspector, \$10,000; Board of Appeals, \$5,000; Planning Board, \$10,000; Soil Conservation Board, \$5,000; Board of Health, \$48,300; Police Department, \$60,000; School Department, \$60,000.

ARTICLE 9. ARTICLE 11.

A motion was made by Wendy Cochrane and it was seconded that the Town vote to accept the provisions of Ch. 126 of the Acts of 1988, amending Sec. 4 of Ch. 73 of the Acts of 1986, to allow an additional exemption which shall be for all exemptions and none of which shall exceed 25% of said exemption for which they qualify in Fiscal Year 2019.
