

Sardinha Family Trust/Thomas George- Bristol County Wine & Spirits- 40A Public Hearing	<p>6:10pm- Interim- Chairman Jeanne Russo opened the 40A Public Hearing for Sardinha Family Trust/ Thomas George- Bristol County Wine & Spirits, 128 Myricks St. Map 23 Lot 5 requesting a variance for internally illuminated signs. The newspaper ad ran in the Taunton Daily Gazette on 9/23/22 & 9/30/22. All certified mailings were mailed out to the abutters.</p> <p>Thomas George the owner of Bristol County Wine & Spirits came in front of the Board. No abutters were present.</p> <p>J. Russo presided. The petition, plan, and the submissions were reviewed by the Board.</p> <p>Mr. George introduced himself to the board. He told the Board he is planning to open Bristol County Wine & Spirits at 128 Myricks St. hopefully in the next couple of weeks. He came to the Board for a variance to illuminate the outdoor signage for Bristol County Wine & Spirits, due to the By-Laws a variance is needed for all internally illuminated signs. All the businesses in the area have illuminated signs. He feels they need the illuminated signs to be competitive in the area. He is not able to put a sign out by the street like Dunkin Donuts, so he needs the sign illuminated at the store front. The Board went through the plans of the sign with Mr. George. The sign is black lettering during the day and lights up white at night time. He tried the best he could to match the Dunkin Donuts type of sign to fit in with the plaza. The sign is up on the building now, just not lit up until the variance is finalized and the approval from the building inspector. The Board was very happy with the plans of the sign. There will possibly be small lit signs in the window from beer companies, but not flashing. Jeanne Russo asked about the store. Mr. George told the Board he is hoping to be open from 8:00am to 9:00pm during the week and maybe open until 10:00pm on the weekends. He will be selling beer, wine, lottery, tobacco, and small snacks. There were no abutters present at the hearing. T. Carmo made a motion to close the Hearing. M. Oliviera seconded. The Board further discussed. All agreed they have no problem with the illuminated signs, all other businesses in the area have light up signs. M. Oliviera made a motion to approve internally lighted signs for Bristol County Wine & Spirits. T. Carmo seconded.</p>
