The newspaper ad ran in the Taunton Daily Gazette on 8/14/23 & 8/21/23. All certified mailings were mailed out to the abutters. The Newspaper article was read into the record The Chairman stated the voting members would be himself, Marc Oliviera, & Meghan Connolly. One abutter was present. The applicants Jose & Moriah Botelho were present. Mr. Jose Botelho came in front of the Board and introduced himself. He explained to the Board he had gone to the Building Inspector after he started to build a front porch. He was told he would need a variance because he was short on the front set back from the deck to the road. He only has 28 feet from the deck to the road and needs 50 feet. The Building Inspector has the plans for the front porch. Mr. Botelho told the Board he had already started the framing of the porch before speaking with the Building Inspector. The Building Inspector told him to stop the work after putting the center tubes in. The porch will be 10 feet by 20 feet. The stairs will be off the front of the porch. The Board reviewed the front of the house on Google Earth online. M. Connolly asked how many stairs there would be and if there would be a railing. Mr. Botelho stated there will be 3 steps with a railing. All further discussed. The Chairman opened the Hearing to the abutters with any questions. The Board all agreed since the porch has already started to be constructed and the Building Inspector is involved with the needed variance they were satisfied.
